Mr. Nye,

My staff has created a CD with the data you requested in your public records request. It is available by visiting Sally Lewis in the County Manager's Offices on the 3rd floor of Building C at the Government Center in Viera. We pulled together data based upon previous requests. There may be slight differences to today's environment because of very recent moves, adds and changes, but this happens daily.

Based upon our telephone conversation Wednesday, we made the following changes to your request:

1. For items 1-3 below, instead of providing 3 years worth of invoices, we are providing listings of our facilities, number of users, ports, equipment and circuits.
2. Item 4 is exempt from public record laws due to the inherent security issues involved. You are welcome to come into our offices and have us review our existing network with you.
3. Items 5 -7 are provided as requested.
4. I have excluded the 911 network due to the fact that it crosses multiple governmental organizations.

Due to the complexity of the request and the change in scope from our telephone conversation, please let me know if you feel we haven't met your needs. My staff and I are available for a more thorough discussion on these issues. I would like to remind you that we will be discussing updating our agreements with AT&T for 3 years at Tuesday's Board meeting. Items III.B.10 and VII.B.4 will be of interest.

Mr. Tipton, I am seeking the information below under the Freedom of Information Act.

I have attempted to obtain what I was looking for through the county's public online records system, but I am unable to obtain many of the documents I am seeking and the level of detail I am seeking on most of the others. I would appreciate it if you could make the following available for me at your earliest convenience:

- 1) All invoices from vendors providing cellular telecommunications services for the last three years.
- 2) All invoices from vendors providing voice telecommunication services; i.e., copper phone lines, T1s, PRIs, etc. for the last three years.
- 3) All invoices from vendors providing data telecommunications services; i.e., MAN, MPLS, T1, PRI, DSL and Cable data/Internet connections for the last three years.
- 4) Copy of network diagrams for Brevard County and all facilities for which the Brevard County IT Dept supports/bills.
- 5) Breakdown of annual personnel/payroll costs in dollars as they relate to the county data network versus voice communications; i.e., how much personnel and dollars is dedicated to maintenance of the data network and how much dedicated to the phone system.
- 6) Copies of all current data and voice equipment support/maintenance contracts and dates of expiration/renewal for each.
- 7) Copies of all current contracts and/or term agreements with any of the vendors from lines two and three of this request with expiration/renewal dates for each.

If you can put it all on CDs or a DVD that would be great - no need to waste a ton of paper. I will pay the requisite fees for the media. Please call me at 321-626-9791 with questions. If you could give me a timeline as to when the information will be available it would be greatly appreciated.
